

It is necessary that the household as a whole fits at least one of the following conditions ①—⑧. (A household here means all members living together and/or members making a living on the same financial basis. It may be different from the household registered on the resident registration.)

(Note)

- A. Your household income for Reiwa 5 (2023) must be filed.
- B. If you lived in Nishinomiya (as of Jan 1, 2024) and filed your household income at Nishinomiya Tax Office or Nishinomiya City Hall, Citizens Tax Division (Shiminzei-ka) you do not need to attach the Taxation Certificate or Tax Notice.

If you live in Nishinomiya but have information of your income outside Nishinomiya City, it is necessary to attach the Taxation Certificate or Tax Notice (A document that proves the income).

- C. If you lived outside Nishinomiya (as of Jan 1, 2024), it is necessary to attach the Taxation Certificate or Tax Notice (A document that proves the income).

※Withholding Certificate, Proof of Tax Return, nor Special Collection Tax Notice will not be accepted. If there are two or more income earners in the household, please submit all the Taxation Certificate or Tax Notice of all of them.

However, if you lived overseas on Jan 1, 2024 and did not have resident registration in Japan, thus cannot submit the Taxation Certificate or Tax Notice, please submit your Withholding Certificate to confirm your income in Reiwa 5 year (2023).
